- 40 Year Term Low Interest Direct Loans and Grants (and Loan Guarantees (80%) pops 50,000 and less)

  - Oct 2022 Quarter 1: 3.5% market, 2.75% intermediate, 2.5% poverty

- Alternatives Considered

  - Cost Estimates for Each (including O&M)
- Selection of an Alternative
  - Present Worth Life Cycle Cost Analysis
- Proposed Project (Recommended Alternative)
  - Basic Design Information
  - Total Project Cost Estimate
  - Annual Operating Budget
    - Income (Proposed Rate Schedule)
    - Equivalent Dwelling Units (EDUs)/Flow Data
    - O&M Costs
    - Debt Repayments
- Reserves (Debt Service and Short Lived Assets)
- Engineer's Recommendations

## Water and Environmental Programs — Direct Loans (Grants)

## **Dwelling Units (EDUs)/Flow Data**

- Get 4 figures
  - Total Gallons sold to Residential Users
  - Total Gallons sold to Residential and all other Users
  - Total number of Residential Connections
  - Total System Revenue (if possible)
    - Sales
    - Taxes and fees
    - All other income
- Calculations
  - Total gallons sold to residential users/total number of residential customers/ 12 months = GALLONS in an EDU
  - Total gallons sold in gallons/ GALLONS in an EDU = TOTAL NUMBER OF EDUS IN THE SYSTEM

## Community Facilities – Direct Loans

#### **Objective**

 Provide financing for essential community facilities for rural communities. These amenities help increase the competitiveness of rural communities in attracting and retaining businesses that provide employment and services for their residents.

#### **Population**

Rural area with population of 20,000 or less

#### **Financing Type**

- Direct Loans and Grants (and Loan Guarantees (80%) pops 50,000 and less)
  - Revenue, GO, Lease Back
  - Oct 2022 Quarter 1: 3.5%

## Community Facilities – Direct Loans

#### **Uses & Project Types**

- Build and rehabilitate facilities
- Recovery residences transitional housing up to 2 yrs
- Fire and rescue vehicles and equipment
- Educational Facilities
- Rural transportation
- Dependent Care Facilities
- Early warning systems
- Public Safety Services, Health Clinics, Schools, Libraries, Hospitals, etc.

#### **Terms/Conditions**

- Up to 100% of market value
- Up to 40 years or useful life of the security
- 3.5% Interest Rate (October 2022 quarter 1)
- Service areas with MHI below \$50,206 can be considered for grant assistance (15-75%)


